<u>CALL TO ORDER</u>: Chairman Mike Tomy called the Northern Regional Plan Implementation Committee (NRPIC) meeting to order at 9:40 a.m.

<u>PLEDGE OF ALLEGIANCE</u>: Chairman Mike Tomy led those assembled in the Pledge of Allegiance.

APPROVAL OF MINUTES: The February 26, 2021, meeting minutes were reviewed. Vice Chairman Ed Pappas made a motion to approve the minutes as submitted, and Beaufort County Councilman York Glover seconded the motion to approve. There was unanimous support for the motion.

<u>CITIZEN COMMENTS</u>: There were none.

PRESENTATIONS:

Colonel Warren Parker, Chairman and Executive Director, South Coast Cyber Center, presented an overview of the Center's vision and goals for the future: cyber defense education, cyber technology curriculum, and additional workforce development.

Mr. Jim Remlin, Sherwood Design Engineers, presented information regarding the MCAS Beaufort and MCRD Parris Island Military Installation Resilience Review Study which included

mission/goal of the project and stakeholder engagement strategy. The process is scheduled to begin within the next two (2) weeks.

DISCUSSION ITEMS:

Chairman Mike Tomy led discussion regarding updates to the PRIORITIZED LIST OF ACTION ITEMS FOR THE NORTHERN BEAUFORT COUNTY REGIONAL PLAN IMPLEMENTATION COMMITTEE TO ADDRESS IN 2021.

- **Review of NRPIC Mandate** The IGA wording is solid and simply in need of an update with all municipalities working as a group/subcommittee. (Bft County, City of Bft, Town of Port Royal, and Town of Yemassee)
- Lady's Island Plan The LICPC is scheduled to meet Monday, April 19, 2021. The LI Village Center Task Force has approved their Mandate and are currently working with the County's Engineering Dept. Stantec, a transportation engineering and planning firm, has been hired by the County to assist with the project over the next four (4) to six (6) months. Penny Sales Tax Projects: connector roads, connector pathways, and improvements to Sea Island Parkway
- Local options sales tax recently a SoLoCo agenda item; Town of Yemassee to update the group regarding their collections
- Uniform yard waste policy will revisit in the future
- Curb-side pickup will revisit in the future
- **Regional stormwater** Ms. Katie Herrera, Beaufort County Stormwater Dept., will present an update (new stormwater Ordinance) at the April 23, 2021, NRPIC meeting. The Town of PR presented at the March 2021 MPC. The City of Beaufort is planning an April 2021 presentation.
- Bike & Pedestrian pathways A Bike/Ped meeting is scheduled for April 13, 2021, to review/revise the final draft document. SCDOT has hired Kimley-Horne to assist with the statewide planning process. County Councilman York Glover reminded everyone about the Harbor Island Bridge missed opportunity. Mayor Joe Devito also mentioned the Broad River Bridge missed opportunity. Noah Krepps, Beaufort County Long Range Planner, will give an update at the April 23, 2021, NRPIC meeting.
- Convenience Centers Still working through decal issues; the solid waste and recycling enterprise system will become a line item on County tax notices there will be no increase in taxes assessed
- Plastic bag ban recycling issues will readdress post COVID
- Regional / Community Parks Robert Merchant was asked to make requested revisions to the parks list and reroute for the April 23, 2021, NRPIC meeting.
- Consolidated fire service will revisit in future after Burton FD litigation resolved
- **Direction of growth development** Comprehensive Plans in draft form
- Workforce development will revisit in future
