VI. NEW BUSINESS

Neighborhood Assistance Program Budget Update

Fiscal Year 2024 started on July 5th and the approved Neighborhood Assistance Budget is \$290,000.

To date two homes have been serviced at a total of \$19,190. Six homes are lined up to begin in the next week with services varying from roof repairs to broken windows.

Staff joined with the Bluffton Township Fire District and had our first smoke detector installation on Wednesday, July 19 and the second installation on Wednesday August 2. In total we supplied 49 smoke detectors throughout 13 homes.

August 3, 2023

Commissioner Magill asked what the total was spent last year on the Neighborhood Assistance Program. Staff will provide the amount at the September meeting.

Commissioner Staples asked where staff got the list of names for the smoke detectors. Smalls answered that these are homes that we have already serviced over the years, and she made calls to see if these families wanted to have their detectors inspected.

VII. PUBLIC COMMENTS

There were no public comments.

VIII. DISCUSSION

1095 May River Road update was given by Chairman Hamilton and Commissioner Wood. Chairman Hamilton stated that there is no significant update to make but there is progress being made. One thing that stood out is the design of the structure fits in with its surrounding area and the other homes nearby.

There will be three buildings, four units each totaling 12 homes. The three bedrooms will be a little over 1500 sq ft and the two bedrooms will be just under 1200 sq ft.

One of the dilemmas we are being faced with right now is permitting and the timeframe for permit approval.

Commissioner Wood believes the units look nice on paper. Wood mentioned that he let the builders know that they must try and keep the material cost down so that we can afford to build.

Commissioner Staples asked if there were any dates available on when the units would be ready for occupancy. Chairman Hamilton answered that timing all plays a part with permitting issues and time frame. Once permitting is approved, the timeframe would be 180 days from when they get permitted.

Smalls let the committee know that there have been a lot of requests for foundation repairs, and that is a job that the Town cannot cover at this time. But they're other agencies that these families can be referred to.

Commissioner James mentioned that certain lumberyards in the area maybe willing to donate scrap lumber or other material for some repairs.

The budget for Fiscal Year 2024 Neighborhood Assistance Budget has been approved at \$290,000.

To date 13 homes have been serviced for home repairs such as roofing and interior repairs totaling \$115,840. Two homes have been serviced for septic pump out, totaling \$800 and one home for tree service totaled at \$5,500. As of today 16, homes have been serviced through the Neighborhood Assistance Program.

Four homes will be visited by staff to evaluate homes for repairs, five homes are waiting on estimates and applications are still being accepted.
