#### **INFORMATIONAL ITEMS**

Organization overview/ Beaufort Jasper Hampton Comprehensive Health Services, Inc. – Roland Gardner, CEO

Mr. Gardner, CEO Beaufort Jasper Hampton Comprehensive Health Service, discussed the history of Beaufort Jasper Hampton Comprehensive Health Services, Inc. It was formed in 1970 and the mission of the health center at that time, was to provide quality affordable, accessible and comprehensive health services to the South Carolina Low Country.

BJCH received a grant in 1969 and started serving patients in 1970. It was a site grant to receive and provide facility services from the OEO program in Beaufort County. In 1970 Beaufort County was featured on NBC News and in Esquire Magazine regarding the poverty in the County and that's how things got started. In 1974 BJCH, under Federal mandate, implemented a Financial Plan to reduce reliance on Federal funds and increase patient, local government, and other grant support.

In 1999, BJCH started seeing an influx of AIDS patients and received "original" Ryan White Part C funding grant from the Federal government.

In 1998 BJCH spent a half a million dollars on medication for Ryan White patients.

In 1999 BJCH expanded into Hampton County per the federal government therefore, becoming BJHCHS.

In 2016 BJHCHS was awarded a separate grant to provide services and housing for Ryan White patients.

2018 BJHCHS received a regional grant to help with providing services to other Ryan White patients in Beaufort, Jasper, and Hampton Counties.

BJHCHS's main site is the Ruth P Field Medical Center Chelsea, which was donated by Ruth P Field in 1969 who lived at Chelsea Plantation, whom also trained the first nursing staff. The Leroy E. Bowne Medical Center in St. Helena provides medical and dental services and has a senior citizen center. The Elijah Washington Medical Center in Sheldon is named for Mr. Washington as he was the first physician that came back to Beaufort to serve BJHCHS after having Senator Thurmond and Senator Hollings request his early release from the Army in 1974. Mr. Washington retired approximately 9 years ago and has delivered over 10,000 babies in Beaufort and Jasper County. The Port Royal Medical Center was dedicated in 1996 with a grant received from the Town of Port Royal. Along with the Chelsea Medical Center the Port Royal Medical Center offers the most comprehensive medical services: Family Practice, Internal Medicine, Pediatrics, OB/GYN, Dental Services, Medical Social Work Services, Pharmacy Services, Radiology Services, and Same Day Clinic. BJHCHS the oldest

medical center in Beaufort County besides Beaufort Memorial Hospital. Along with the medical /dental services provided SCDHEC has designated BJHCHS as the regional medical services provider for Ryan White/HOPWA medical care for more than 230 patients. Beaufort has been ranked healthies county in SC for the 9<sup>th</sup> straight year.

Dr. Florence Ferguson stated BJCHS currently has a grant regarding the OPIOD crisis and has partnered up with Beaufort County Drug and Alcohol to treat patients.

Mr. Gardner stated total operating cost is 22 Million dollars. During 2017-2018 \$5,134,112.00 worth of medical care was provided to Beaufort County residents living below federal poverty guidelines for which BJHCH was not reimbursed for services. Services included: Medical visits/supplies, Dental visits/supplies, Radiology charges, referral to labs, and Pharmacy. BJHCH has 270 employees and salaries exceed 13 million dollars each year. 8 million dollars comes from the federal government and the rest comes from patient fees and insurance. Percentage of population being treated in Beaufort County is 68%. 57% are adults, 31% are children and 12% are elderly. 9% have Medicare, 35% have no health insurance, 31% are Medicaid, 23% are privately insured and 2% have other public programs. There are 1,300 community health centers in the Country serving 22-18 million patients. Each of these health centers compete each year for federal funding. BJHCH is currently within the school system with the Ronald McDonald House through Monica. BJHCH is now at 21 schools seeing dental clients.

Dr. Faith Polkey spoke about the local medical school in Beaufort. AT Still University is an osteopathic medical school that was actually the first osteopathic medical school in the country located in Missouri in the 1800's. About 15 years ago it expanded to Arizona and then decided to do something different by training students in the communities. One of the founders worked with the National Association of Community Health Centers and wanted to train students in the community health center. The students came to your campus and were a part of your community. The students spend the first year in Arizona and then transfer to the different community campuses which includes BJHCS. 2<sup>nd</sup> year at the community health center gives them an early introduction to clinical practices. 3<sup>rd</sup> and 4<sup>th</sup> year they transition to the hospitals and communities to train them. The purpose of the school is to bring back services to the underserved areas. There is a home town program that can by endorsed by the community health center if they are personally known at the community health center. Example, Dr. Supan's son Pete was endorsed by BJHCH. Graduated a total of 8 classes. 67% went into primary care.

Councilman Covert asked since BJHCHS receives funding are they under the requirements of JACO? Dr. Ferguson stated BJHCH does not use JACO they use PCMH for accreditation. They have used JACO in the past but it seems to be more specific to Hospitals and is quite expensive and not made to ambulatory care. Mr. Garner interjected that BJHCH went with PMCH to receive NCQA certification because by getting that certification the federal government will supplement grants when you are a PCMH site, it enhances funding.

Councilwoman Howard stated she heard great things about BJHCHS's program with the migrant workers.

Dr. Polkey stated their unique program provides a night clinic from 7 until. This way they don't have to take off from work because if they don't work they don't get paid. BJHCHS provides medical, dental, OB, etc. It also provides transportation services. Last year there was an unexpected flu outbreak

and BJHCHS collaborated up with Beaufort Memorial to assist in treating the workers for which BJHCHS recieved National recognition being named Outstanding Migrant Health Center of the Year and Mr. Gardner received a lifetime achievement award as well.

<u>Update Alcohol and Drug Abuse Department</u> – Steve Donaldson, Director, Alcohol and Drug Abuse Department.

**Discussion:** Called BCADAD. Some history. Back in 1957 the same year Hilton Head was incorporated, the South Carolina Alcoholics Center was created to basically provide programming as it relates to alcohol around the state, they also opened the first inpatient treatment center in Florence called Palmetto Center and it is in the process of being rebuilt. 1966 they were renamed to SC Commission on Alcoholism as an independent agency to address prevention and control of alcohol related problems. In 1971 there were extensive hearings in Columbia which lead to them to recognizing the need to address the drug problem. Developed the Office of the Commissioner of Narcotics and Controlled Substances. 1973- Act 301 was created to provide a more robust prevention services in the counties of the state of SC. There are 34 different alcohol and drug prevention offices for 46 counties. Alcohol and Drug was incorporated together to create the SC Commission on Alcohol and Drug Abuse (SCCADA) Beaufort County Department of Alcohol and Drug Abuse was created this year as well. This is prevention, intervention and treatment. 1993 SCCADA was renamed the SC Department of Alcohol and Other Drug Abuse Services (DAODAS) and made a cabinet agency as part of government restructuring. About BCADAD, a small operation spread out in a big county.

They have 19 full time employees with 5 full time and a part time grant funded positions that have not all been filled yet. The department is CARF accredited, Commission and Accreditation of Rehabilitation Facilities. Drug Abuse Board is appointed by council and has 7 members, which a very diverse group in ethnicity, gender, previous treatment, no treatment and professionals. Meetings are held bi-monthly on Wednesdays at 4:00 pm in the County Administration Building. Together, the Board and Department are available to advise Council, staff, and other stakeholders in matters concerning the provisions of ongoing programs in prevention, intervention, treatment and aftercare for alcohol and drug misuse (including nicotine) and related problems. To that end, BCADAD is an ATOD Department also helping with tobacco, vaping and juuling. There are 2 locations. One in the Beaufort County Human Services Building Second is in the Bluffton Government Center and evaluation location is being reviewed. New vision, new director, started in September 10, 2018 and then gave the staff off due to a hurricane. His focus was taking a look at Evidence Based Treatment practices, they have few, a very dedicated staff and were good to the patients. One thing he recognized that if they were going to have Evidence Based Treatment approaches through a robust capacity building plan so that the department is using therapeutic interventions that are supported by science, such as Seeking Safety. Motivational Interviewing (MI) Medication Assisted Treatment (MAT) and others. Trying to collaborate with medical practitioners in the community because BCADAD needs to have medical involvement. There is state funding available for this through the opiate grant. Seeking small grants, recurring state funding for school based programs, prevention, and one time monies from the state for infrastructure fund to make facility improvements. There is a 4- million- dollar proposal for facility improvement in the works.

BCADAD serves adolescents 12-18, men and women 18 years of age and older, prevention services those from birth to earth. 1 adolescent Outpatient (traditional and school programming such as SCiP and Bridge, which is new. A part time adolescent counselor will be embedded in a right choices

program for children with alcohol and drug problems. Adult Outpatient and Intensive Outpatient only difference is outpatient is less than 9 hours a week and Intensive Outpatient is 9-19 hours a week. There are classes during the day and in the evening, 60% patients are working, by the time they leave 80% will be working. Alcohol Driving Safety Action Program, that is services for DUI and BUI Beaufort Counties are going up in alcohol consumption. Offender based Intervention, Drug Court, Screening Intervention Referral to treatment, Prevention for tobacco, juuling and vaping.

Narcan Distribution is set up for anyone can go to BCADAD to receive Narcan to help with overdosing. Current Goals, Reviewing all contract for compliancy and effectiveness through legal. Setting up systems to ensure financial integrity, including the desire to participate in the Debt Set-Off Program, BCADAD believes that people who can afford their treatment should. There is federal funding for indigent care and everyone has a financial screening before treatment. Evaluating personnel function and productivity standards. Improving the department's use of technology, getting rid of the written policy and procedure manual that was located in the office. Creating a plan for clinical staff development, and developing new partnerships and funding streams. One of the new partners in BJHCH, wanting to strengthen the partnership with the schools and solicitor's office. Progress, Reduction of contractual expenses, stronger accounting, including collecting \$40,000 in debt, acceptance of credit cards for patients that can afford to pay for treatment, productivity of staff is tracked which has led to greater efficiency and utilization, the use electronic surveying stakeholders satisfaction, enhanced treatment services that utilizes Recovery Oriented System of Care and chronic disease language with matching interventions, development of strong relationships within the medical community, positioned as helpers with the Opioid epidemic through resources obtained through the State Opioid response and designation as a Narcan distributor at no additional cost to the County.

Councilman Covert asked what is the relationship or open door between BCADAD and the Sheriff's Department, Police Department, Corner's office specifically with the Opioid Problems.

The Corner participates in one of the forums with the opioid crisis. The Sheriff Department participated with the DEA take back events through prevention department. One of the grant's is specifically designated to information dissemination and training in the community, having more community forums and public service announcements. There is a relationship and coalition built, prevention believes in coalition building.

Item: Fiscal year 2020 Community Services Grant recommendations from the Beaufort County Human Services Alliance to local non-profit agencies in the cumulative amount of \$398,000—Fred Leyda, Director, Human Services Department

**Discussion:** As a County department since 1974, we support all residents by leading policy innovation, inspiring collaborative solutions, and facilitating partnerships to improve quality –oflife while maximizing resources. Together for Beaufort County (T4BC) is an organizational framework that enhances our community's capacity to address social problems taking 120 different organizations and putting them all on the same page. A lot of organizations do great work but they work independently and want to try to connect these organizations together to increase the impact of the community. The Human Service Alliance coordinates collaborative activities, provides shared measurements for success, and facilitates the development of shared vision among diverse community partners The purpose of the grant program promoting and sustain activities that improve quality-of-life for all Beaufort County residents. The program was established by the county council as a competitive grants process its eligible to all nonprofit members of the alliance and membership of the alliance is free, you must attend 75 % of the meetings. Eligibility requires being registered as a 501(c) 3 non-profit in good standing, serve Beaufort County residents, active participant in achieving Together for Beaufort County goals and objectives, Registered Human Services Alliance partner. Grant applications are due at the end of July it is an annual cycle and a competitive process and then funds are awarded by county council as result of the recommendations. Ineligible Activities, you are not allowed to ask for funding for Capital Improvements, Religious or Political Activities, Endowments or Sub grants, Fund raising Campaigns or Events, Debt or Encumbrances. Direct subsidies are not allowed to be requested because Council has developed a fund specifically for that the emergency assistance fund. Review process is a competitive process, received 24 applications, a total of \$490,000.00 in requests, and Human Services is only awarded \$398,000.00 so the goal of the review panel was to limit that down to the \$398,000.00. Review Panel is to prevent lobbying, they do not know each other and remain anonymous until they sit down at the table. Each application is evaluated by a diverse volunteer panel of community professionals. Applications evaluated on their own merit using a competitive process, they score every application using a scoring matrix. Panelist are chosen based on demographics, skills, experience, and participation with the Together for Beaufort County process. New volunteers are invited every two years on a staggered rotation.

Councilman Covert asked Mr. Leyda to elaborate on eligible activities.

One of the things that they allow is operating expenses. They don't limit the stuff that they can't do as long as they build and collaborate with other agencies. Most of the organizations that applied are receiving the amount they requested. Past Successes, was Bluffton Self-Help, had 1,000 visits, placed people in full time and part time jobs and had 3 student got their GED. Low country Food

Bank's Cooking Matters Program, Provided evidence-based nutrition and cooking classes to over 400 mothers and children eligible for SNAP benefits.

Planned Activities for FY20; provide outreach and support services to ensure the economic and social wellbeing of at-risk children and families through Bluffton Self-Help, assist with job applications and helping families become self-sustainable, supporting volunteer-based medical clinics that provide safe, high-quality healthcare services to eligible residents and enhance cross-sectoral, multidisciplinary civic engagement activities.

Councilwoman Howard asked what Safe Harbor was.

Mr. Leyda stated Safe Harbor is one of the groups that is under a coalition for aging in place for preparation for elderly not having the sufficient bed space in facilities for rehabilitation etc. We currently have 3 villages, Safe Harbor is in Hilton Head, Staying Connected in Sun City, Caring Neighbors. They would like to get one in St. Helena, Burton area, Sheldon township area. They help with care and bringing services into their home through volunteers and keeping the elderly out of other facilities.

Motion: It was moved by Councilman Dawson, seconded by Councilman Hervochon to approve the community services grants program. The vote: YAYS — Councilman Hervochon, Councilwoman Howard, Councilmen Passiment, Councilman Covert, Councilman Dawson, Councilman Lawson. The motion passed.

Item: Potential New Riverside branch for the Beaufort County Library System - Ray McBride, Library Director

**Update:** Mr. McBride came before the committee in August with a proposal to build a library in the Riverside are. Asking permission for the community services committee to approve the project to move forward to the finance committee. Recap proposed project overview, e.g. listed in CIP, \$6.5 million dollar cost to build, timing relevant due to all the construction around that site, population and development boom in Bluffton/Pritchardville area; and likelihood of future prime sites opportunities. Recommendation is to borrow full mount for purchase and use impact fees for repayment. There should be absolutely no problem accruing impact fees down the road.

# A RESOLUTION OF BEAUFORT COUNTY, SOUTH CAROLINA, ENCOURAGING THE SOUTH CAROLINA GENERAL ASSEMBLY TO ADOPT H. 3063, "HATE CRIME BILL."

WHEREAS, according to the Federal Bureau of Investigations, in 2017, hate crimes across the United States rose by 17 percent and nearly three out of five incidents were related to race and ethnicity ("Incidents, Offenses, Victims, and Known Offenders by Bias Motivation, 2017"); and

WHEREAS, South Carolina is one of only five states in the United States that does not have any laws on hate crimes; and

WHEREAS, H. 3063 is currently being considered by the House Judiciary Committee; and

WHEREAS, H. 3063 provides penalties for persons convicted of a crime with the intent to assault, intimidate, or threaten a person because of race, religion, color, sex, age, national origin, sexual orientation, or homelessness; and

**WHEREAS**, Beaufort County Council desires to protect and promote the health, safety, welfare, and quiet enjoyment of all residents and visitors.

**NOW, THEREFORE BE IT RESOLVED**, Beaufort County Council, in a meeting duly assembled hereby expresses its support for H. 3063, "Hate Crime Bill."

#### Issues for Consideration:

The Beaufort County Disabilities and Special Needs (DSN) Department would like to purchase two new Ford Transit conversion vans from Ilderton Conversion Company, a State contract vendor. The vans are needed to accommodate program growth. Two 148" wheelbase vans are for the Adult Employment (Day) Program. They are designed for up to ten passengers and two wheelchairs and have a higher roof and dual rear wheels. Increased engine size and heavier frame are needed due to the weight of the large powered wheelchairs. The backup cameras, L track and Qstraint wheelchair restraints are necessary safety features. DSN's vehicles travel long distances daily, often on unpaved roads, which contributes to constant wear and repairs. The safety of the consumers served by DSN is paramount.

#### Points to Consider:

- 1. Per Jeremy Kircus, General Manager of First Vehicle Services, our existing vehicles 23107 and 22911 should be removed from our fleet as both unsafe and not economically feasible to continue repair. These two new Transit vans will replace those vehicles.
- 2. Total cost for two Vans: \$110,882.

#### **Issues for Consideration:**

- The Library System is seeking to use library impact fees in the amount of \$44,000 to McMillan/Pazdan/Smith Architects, an approved vendor on the Beaufort County Architectural and Engineering Master Registry for projects under \$50,000, for the purpose of funding architectural and engineering services for the partial interior renovation of the children's area at the Bluffton Branch based on the completed Library Interior Space Study dated March 2019.
- The Library Board of Trustees approves the expenditure.

#### Points to Consider:

- Bluffton library 16 years old.
- Current door count at Bluffton library is over 14,000 visits per month.
- Interior space utilization study of March 2019 determined that the current children's department area is far too small to serve the number of children using the library.

#### **Funding & Liability Factors:**

- Library impact fees can be utilized for the proposed project.
- Bluffton library impact fees currently at \$3,071,130.
