Gentlemen,

I wanted to take this opportunity to report to you on the recent activities of the Lowcountry Economic Alliance regarding the current and proposed new bylaws.

As you will recall, the Alliance Board passed a new set of bylaws for your consideration in November of 2012. While both counties reviewed the document, there was not a clear path moving forward for modification and adoption of a new set of bylaws that both counties could endorse.

The original bylaws require that both counties adopt any modifications thereby requiring unity in a path moving forward.

Over the last few weeks the bylaws discussion became much more complicated than I anticipated. In our efforts to guard against any unintended consequences we lost sight of the fact that there is no perfect document and we needed to leave ourselves flexibility for future Alliance investors to speak as well.

With that realization, we spoke to our legal counsel about options for flexibility moving forward. The Alliance Board took the components of the bylaws that we needed for operation purposes to engage the additional investors and adopted them as policy. As the new board grows and becomes better defined by its investors it may revisit the bylaws issue.

At this time the Alliance is governed by the original bylaws set out by both counties and has a set of policies governing the work of the organization. Of course, policies can be changed by a simple majority of the Board whenever it sees fit.

I appreciate your patience with us on this process.






