e. Second Reading of Proposed Ordinance 2013-12

Second Reading of Proposed Ordinance 2013-12 of the Town of Hilton Head, South Carolina, authorizing the granting of an easement encumbering real property owned by the Town of Hilton Head Island, South Carolina, commonly known as "Barker Field Expansion", being 17.56 acres on Mitchelville Road, pursuant to the authority of S. C. Code Ann. § 5-7-40 (Supp. 2010), and § 2-7-20, *Code of the Town of Hilton Head Island, South Carolina*, (1983, As Amended); and providing for severability and an effective date.

Mr. Harkins moved to approve. Mr. McCann seconded. The motion was approved by a vote of 5-0.

10) New Business

e. Consideration of a Resolution – Distance Requirements

Consideration of a Resolution by the Town Council of the Town of Hilton Head Island directing staff to pursue an amendment to the Land Management Ordinance (LMO) to eliminate the distance requirements between an auto sales site and an existing residential use.

Mr. Williams moved to approve. Mr. McCann seconded. Mr. Riley stated the specific request was regarding the separation standards. He said the LMO Rewrite Committee is actually looking at proposing eliminating all of the standards and staff is in agreement. It was the consensus of Council to only address the issue at hand. The motion was approved by a vote of 5-0.

f. First Reading of Proposed Ordinance 2013-13

First Reading of Proposed Ordinance 2013-13 to repeal Chapter 7 of Title 9 of the Municipal Code of the Town of Hilton Head Island, South Carolina and to reenact a new Chapter 7 of Title 9, open burning; and providing for severability and an effective date.

Mr. Harkins moved to approve. Mr. McCann seconded. After discussion of the contents of the proposed ordinance, a typographical correction was made within Attachment A under Section 9-7-20, Item (d), (8) with the removal of the word "recreational". Council also concurred that staff should look at ways to educate and assist those with large pieces of land and in need with removal of yard debris. It was suggested a plan be prepared for review at a future Town Council meeting. The motion was approved by a vote of 5-0.

g. Consideration of a Recommendation – CDBG Entitlement Community Eligibility

Consideration of a Recommendation that the Town Council of the Town of Hilton Head Island declines participating in the United States Department of Housing and Urban Development Community Development Block Grant (CDBG) Entitlement Program.

Mr. Williams moved to approve. Mr. Harkins seconded. Mr. Riley explained the difficulties concerning participation in the program. Mr. Harkins noted he understood the potential dollars received are outweighed by the administrative burden. Mr. Grant indicated interest in the program for teachers and police officers noting the high cost of rent on the Island. Marcy Benson reviewed some of the criteria for participation in the program explaining it is very difficult to meet and follow the requirements. After discussion by Council, it was decided that the issue should be reviewed in depth at the upcoming Town Council Workshop so Council could be better prepared to evaluate when the program is offered again next year. The motion was approved by a vote of 5-0.

h. First Reading of Proposed Ordinance 2013-14

First Reading of Proposed Ordinance 2013-14 to amend the Municipal Code of the Town of Hilton Head Island, South Carolina; to amend Chapter 1 (Beaches) of Title 8, Beaches, Waterways and Recreational Areas, Part A, General Beach Prohibitions, Section 8-1-211 (17), Unlawful Activities Enumerated; and providing for severability and an effective date.

Mr. Harkins moved to approve. Mr. McCann seconded. The motion was approved by a vote of 5-0.

i. Consideration of a Recommendation – Fire Station #6 Project

Consideration of a Recommendation that the Town Council of the Town of Hilton Head Island authorize the Town Manager to execute a work change directive not to exceed \$375,000 regarding the Fire Station #6 Project.

Mr. Harkins moved to approve. Mr. Williams seconded. Scott Liggett explained the need for the change directive. He displayed photographs showing the poor condition of the subsurface soils noting the need to pursue additional work to prepare the site for construction. Mr. McCann asked if the company that completed the soil study has any liability. Mr. Liggett noted there are always conditions that go along with the reports which alleviate the liability. Mr. Harkins stated he felt the company does have liability and recourse is needed. Mayor Laughlin suggested Council move forward with this request but still pursue legal advice for recovering funds concerning this expense. Members of Council concurred. The motion was approved by a vote of 5-0.

11) Executive Session

Mr. Riley stated he needed an Executive Session for contractual matters pertaining to land acquisition including possible sale or trade of town-owned land; legal matters pertaining to the Republic Waste hauling contract; legal matters pertaining to potential contractual agreements with Palmetto Hall; and personnel matters pertaining to potential appointments to the Economic Development Board.

At 5:10 p.m. Mr. Harkins moved to go into Executive Session for the reasons given by the Town Manager. Mr. Williams seconded. The motion was unanimously approved by a vote of 5-0.

Mayor Laughlin called the meeting back to order at 6:26 p.m. and the remaining New Business item was handled.

1. Town News

The South Carolina Municipal Insurance Trust (SCMIT) recently completed the Town's Minimum Guidelines Assessment and Loss Control Report Card for 2012. The Assessment measures the Town's compliance with up to 29 criteria, serving as an indicator of our effectiveness in implementing sound risk management policies and procedures. We achieved a compliance score of 104%, making the Town eligible for a Workers' Compensation (WC) contribution credit for the 2014 policy year.

The Report Card provides a summary of the Town's WC loss control history, Minimum Guidelines Assessment compliance, premium analysis and other information helpful in managing our overall loss control program. The Town's 2012 loss control performance was better than the average for SCMIT's member pool of over 100 municipal organizations. These positive results will mitigate any increases in 2014 WC premiums.

AN ORDINANCE OF THE TOWN OF HILTON HEAD ISLAND ORDINANCE NO. 2013PROPOSED ORDINANCE NO. 2013-14

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE TOWN OF HILTON HEAD ISLAND, SOUTH CAROLINA; TO AMEND CHAPTER 1 (BEACHES) OF TITLE 8, BEACHES, WATERWAYS AND RECREATIONAL AREAS, PART A, GENERAL BEACH PROHIBITIONS, SECTION 8-1-211 (17), UNLAWFUL ACTIVITIES ENUMERATED; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Town Council did previously adopt Chapter 1 of Title 8 entitled "Beaches" on May 21, 1984; and

WHEREAS, the Town Council finds it desirable to amend Chapter 1 of Title 8, Section 8-1-211 (9) to facilitate a 350/30 year anniversary in celebration of two historic dates in the history of Hilton Head Island.

NOW, THEREFORE, BE IT ORDERED AND ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF HILTON HEAD ISLAND, SOUTH CAROLINA, AND IT IS HEREBY ORDERED AND ORDAINED BY AND UNDER THE AUTHORITY OF SAID TOWN COUNCIL, AS FOLLOWS:

NOTE: <u>Underlined and bold-face typed</u> portions indicate additions to the municipal code. <u>Stricken</u> portions indicate deletions to the municipal code.

Section 1. Amendment. That Subsection (17) of Section 8-1-211 of the Municipal Code of the Town of Hilton Head Island, South Carolina, be and the same hereby is amended to read as follows:

"Section 8-1-211. Unlawful activities enumerated."

(17) Commercialization. No commercial activity shall be undertaken on the beach on [or] in the waters within the jurisdiction of the town, including the sale, solicitation or offer for sale of any product, real estate or real estate interest, service or activity, the rental or offer of rental of any real or personal property, the distribution of any material, handouts, bills, promotional brochures or similar items, except in conformity with the provisions of this chapter. (See Article III, "Franchising".) Except that an event to celebrate the anniversary of the sighting of Hilton Head Island or the anniversary of the incorporation of the Town, or both, which is approved by the Town, is permitted to be conducted on the beach at the approved location and time.

Any person proposing to operate any commercial enterprise on private property contiguous to the beach shall be subject to all applicable provisions of this municipal code and must possess a valid town business license. (See <u>Title 16</u> regarding development plan approvals.)

<u>Section 2. Severability.</u> If any section, phrase, sentence, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall no affect the validity of the remaining portions thereof.

<u>Section 3. Effective Date.</u> This Ordinance shall be effective upon adoption by the Town Council of the Town of Hilton Head Island, South Carolina.

RE: Proposed Ordinance Number 2013-15, Prohibiting the composition,

reviewing, or sending of electronic messages while operating a motor vehicle

in the Town of Hilton Head Island

DATE: August 1, 2013

Recommendation: The Hilton Head Island Fire and Rescue Chief and the Beaufort County Sheriff have requested that an exception to our ordinance be made for Public Safety personnel while in the performance of their official duties. Staff has drafted the attached Proposed Ordinance Number 2013-15, adding Section 611 (c) (5) to Chapter 1 of Title 12 of the Municipal Code (Text Messaging While Operating a Motor Vehicle), which would create an exception for Public Safety personnel in the course and scope of their official duties.

<u>Summary</u>: This Ordinance prohibits the composition, reviewing, or sending of electronic messages while operating a motor vehicle in the Town of Hilton Head Island, with limited exceptions. This proposed Ordinance amendment would create an additional exception for Public Safety personnel to be permitted to compose, review, or send electronic messages while operating a motor vehicle in the course and scope of their official duties in the Town of Hilton Head Island.

Background:

Recently Town Council passed an ordinance prohibiting the composition, reviewing, or sending of electronic messages while operating a motor vehicle in the Town of Hilton Head Island, and recommended that it be modeled after House Bill 3121, which is currently pending before the South Carolina Legislature. This legislation does not currently contain an exception for Public Safety personnel. This proposed amendment would create an exception for Public Safety personnel in the course and scope of their official duties.

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE TOWN OF HILTON HEAD ISLAND BY ADDING AN EXCEPTION FOR PUBLIC SAFETY PERSONNEL TO BE ABLE TO USE ELECTRONIC DEVICES WHILE OPERATING A MOTOR VEHICLE IN THE COURSE AND SCOPE OF THEIR OFFICIAL DUTIES, BY AMENDING SECTION 12-1-611 (C) OF CHAPTER 1 OF TITLE 12, TEXT MESSAGING; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Town Council has determined that it is in the best interests of the vehicle operators and other vehicles to prohibit the use of handheld electronic communication devices to compose, send, or review electronic messages while operating a motor vehicle within the Town; and

WHEREAS, Town Council finds that Public Safety personnel in the performance of their duties have a special need and requirement for using electronic devices to compose, review and send electronic messages in order to assist them in the protection of the health and safety of the residents and visitors of Hilton Head Island; and

WHEREAS, Town Council now desires to permit Public Safety personnel to use handheld electronic communication devices to compose, send, or review electronic messages while operating a motor vehicle in the performance of their official duties within the Town in the manner provided for in this ordinance.

NOW, THEREFORE, BE IT ORDERED AND ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF HILTON HEAD ISLAND, SOUTH CAROLINA; AND IT IS HEREBY ORDERED ORDAINED BY AND UNDER THE AUTHORITY OF THE SAID TOWN COUNCIL, AS FOLLOWS:

NOTE: <u>Underlined and bold-face typed</u> portions indicate additions to the Municipal Code. <u>Stricken-portions</u> indicate deletions to the Municipal Code.

That Section 12-1-611 of Chapter 1 of Title 12 of the Municipal Code of the Town of Hilton Head Island, South Carolina, is hereby amended by adding Section 12-1-611 (c) 5:

Article 6. TEXT MESSAGING

"Section 12-1-611. Electronic Communications While Operating a Motor Vehicle.

(a) Definitions:

"Electronic communications device" means an electronic device used for the purpose of composing, reading, or sending an electronic message, but does not include a global positioning system or navigation system or a device that is physically or electronically integrated into the motor vehicle.

- "Electronic message" means a self-contained piece of digital communication that is designed or intended to be transmitted between physical devices. "Electronic message" includes, but is not limited to, electronic mail, a text message, an instant message, or a command or request to access an internet site.
- (b) It shall be unlawful for a person to use an electronic communication device to compose, read, or send an electronic message while operating a motor vehicle on the streets and roads within the Town.
- (c) Exceptions. This section shall not apply to a person operating a motor vehicle while:
 - (1) off the traveled portion of a roadway;
 - (2) using an electronic communication device in a hands free, voice-activated, or voice-operated mode that allows the driver to review, prepare and transmit an electronic message without the use of either hand except to activate, deactivate, or initiate a feature or function:
 - (3) summoning medical or other emergency assistance; or
 - (4) using a citizens band radio, commercial two-way radio communication device, in-vehicle security, or amateur or ham radio device.
 - (5) public safety personnel employed by a federal, state, county, or municipal organization who are utilizing an electronic communication device during the course and scope of their official duties.
- (d) Penalty. A person who violates this section is guilty of misdemeanor distracted driving and, upon conviction, shall be fined one hundred dollars for a first offense, two hundred dollars for a second offense, and three hundred dollars for a third or subsequent offense. This fine is subject to all applicable court costs, assessments, and surcharges.
- Section 2. Severability. If any provision, clause, sentence or paragraph of this Ordinance or the application thereof to any person or circumstances shall be held invalid, that invalidity shall not affect the other provisions of the Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.
- <u>Section 3.</u> <u>Effective Date.</u> Ordinance shall become effective upon adoption by the Town Council of the Town of Hilton Head Island, South Carolina.

Recommendation:

Staff recommends Town Council approve the first reading of Proposed Ordinance No. 2013-16 to amend the millage of the General, Capital Projects and Debt Service Funds for the fiscal year ending June 30, 2014 based on the property reassessment performed by the County.

Summary:

Pursuant to Section 12-43-217 of the Code of Laws of South Carolina, 1976, as amended (the "Code"), once every fifth year each county shall appraise and equalize those properties under its jurisdiction ("Reassessment"). Property valuation must be complete at the end of December of the fourth year and the county shall notify every taxpayer of any change in value or classification if the change is one thousand dollars or more. In the fifth year, the county or State shall implement the program and assess all property on the newly appraised values.

Beaufort County has undertaken Reassessment which will be implemented in tax year 2013; and pursuant to 12-37-251(E) of the Code, the number of mills levied for tax year 2013 must be increased or "rolled forward."

Background

With Ordinance No. 2013-05 on June 18, 2013, Town Council enacted a budget for the fiscal year ending June 30, 2014. This budget was based on the County's preliminary projection of a mil with reassessment, a small growth factor, and no millage increase. (The Town did adopt a .29 mil increase in the General Fund with a corresponding .29 mil decrease in the Debt Service Fund.)

Council was informed that the budget ordinance would require amendment when the County issued its final reassessment figures in August, 2013.

In order to meet the required deadlines of the County, the Town will need to have its second reading of this ordinance at its regularly scheduled meeting on September 17, 2013. However, at the present time, the Town has not yet received the County's final reassessment information with which to recalculate the Town's millage. Therefore on the attached proposed ordinance, the value of a mil and the millage rates in total and for each of the three funds are blank.

The County plans to distribute information to the municipalities and public service districts on August 26, 2013. The Town plans to review and recalculate the millage, finalize the ordinance, and prepare a new cover memo to distribute at the September 3, 2013, or earlier if possible. Successful completion of these plans will result in no special Town Council meeting. If the information does not come together as planned, a special meeting will be needed during the week of September 9-13.

Background

Beaufort County has undertaken Reassessment which will be implemented in tax year 2013; and pursuant to 12-37-251(E) of the Code, the number of mills levied for tax year 2013 must be increased or "rolled forward."

With Ordinance No. 2013-05 on June 18, 2013, Town Council enacted a budget for the fiscal year ending June 30, 2014. This budget was based on the County's preliminary projection of a mil with reassessment, a small growth factor, and no millage increase. (The Town did adopt a .29 mil increase in the General Fund with a corresponding .29 mil decrease in the Debt Service Fund.)

Council was informed that the budget ordinance would require amendment when the County issued its final reassessment figures in August, 2013.

The County distributed information to the municipalities and public service districts in late August. Town staff reviewed this information and revised the millage for each fund. Based on the revised millage, the reallocation from the Debt Service Fund to General Fund is now .31 mils. The April 2013 information prior to reassessment valued the Town's mil at \$915,147. Based on the new value of the Town's mil at \$840,326 or a \$74,821 decrease, the Town as a whole averaged an 8.18% decrease.

At this time, staff does not propose any changes in ad valorem (property tax) revenues. Since the reassessment and corresponding revised millage is set prior to property owners receiving their notices and having the chance to appeal, staff will monitor this revenue source closely throughout the fiscal year.

- Real property and personal property tax year 2012 tax billings (part of total tax year 2012 ad valorem tax billings totals) are as of July 31, 2013. As tax year 2012 continues, these figures can and will change due to appeals and 4% applications being processed (some of which could be material).
