# **Meeting Minutes**

## Thursday, November 7, 2019, 3:00 p.m.

#### **ATTENDANCE**

<u>CALL TO ORDER</u>: The Lady's Island Plan Implementation Committee (LIPIC) was called to order at 3:04 p.m.

PLEDGE OF ALLEGIANCE: Those assembled were led in the Pledge of Allegiance.

APPOINTMENT OF CHAIRMAN AND VICE CHAIRMAN: Mr. Paul Butare nominated Allen Patterson for Chairman of the Committee, and Mayor Billy Keyserling seconded the nomination. Mayor Billy Keyserling nominated Paul Butare for Vice Chairman, and Ms. Caroline Fermin seconded the nomination. There was sufficient support for both nominations.

<u>IMPLEMENTATION ACTION MATRIX – PRIORITIES AND STRATEGIES</u>: Action items within the matrix, Leadership, Civic Engagement, Transportation, Community Form, Growth Management, Streetscape, Economic Reuse, and Plan Monitoring, were identified according to cost, timeline, and degree of difficulty.

After discussion among those in attendance, it was decided that a strategic, first step would require prioritizing specific actions items for the Committees' initial focus. Civic Engagement, Transportation, and Growth Management were selected. To assist with the prioritization and strategic planning of these action items, three sub-committees were formed: 1) Civic Engagement/Public Outreach – Chairman Allen Patterson, Vice Chairman Paul Butare, and Ms. Caroline Fermin; 2) Transportation – Chairman Allen Patterson and Mr. Jan Malinowski (sub-committee will coordinate with Mr. Rob McFee, Beaufort County Engineer); and 3) Growth Management – Ms. Rikki Parker and Mr. Chuck Newton. Chairman Allen Patterson will contact Mr. David Gasque regarding the subject of growth management.

During the next Committee meeting, each sub-committee will identify time-sensitive items and report critical path information for the following: action items currently in progress, action items viewed as short-term vs long-term endeavors, and action items identified as ongoing indefinitely. It will also be important to categorize those items which can be addressed within the local Comprehensive Plans.

REVIEW OF DRAFT INTERGOVERNMENTAL AGREEMENT: The Intergovernmental Agreement will establish the Lady's Island Community Preservation Committee (LIPC). Mayor Billy Keyserling stressed the need to institutionalize the Committee and thus, give it structure. Mr. David Prichard and others noted the value in having "another voice" and involving more Lady's Island citizens during the planning/implementation process. The LIPC should be used as a tool to validate the direction taken with many of the action items listed within the Matrix.

The Committee agreed to conduct further review and discussion at the next Lady's Island Plan Implementation Committee meeting scheduled for Thursday, December 5, 2019.

<u>OTHER BUSINESS</u>: The next regular Committee meeting is scheduled for Thursday, December 5, 2019, at 3:30 p.m., Executive Conference Room, Beaufort County Administration Building, 100 Ribaut Road, Beaufort, SC.
