Meeting Minutes

Friday, February 28, 2020, 9:30 a.m.

<u>CALL TO ORDER</u>: Chairman Mike Tomy called the Northern Regional Plan Implementation Committee (NRPIC) meeting to order at 9:35 a.m.

PLEDGE OF ALLEGIANCE: Chairman Mike Tomy led those assembled in the Pledge of Allegiance.

CITIZEN COMMENTS:

Ms. Rikki Parker commented on funding for the Lady's Island Village Master Plan.

Mr. Chuck Newton spoke in regard to economic and environmental planning.

Mr. Joseph Kline shared concerns regarding low public input – Comp Plan.

REVIEW OF MINUTES: The January 24, 2020, meeting minutes were reviewed. Stephen Murray III made a motion to approve the minutes as submitted, and Van Willis seconded the motion to approve.

ACTION ITEMS:

Mr. Glenn Walters, Design Workshop Consultant, presented an overview regarding the 10-year update to the Beaufort County Comprehensive Plan and discussed the scheduling of General Workshops. Comments from meeting attendees addressed sea level rise; information distribution/degree of public participation; importance of all regions working together; housing and cost of infrastructure/fiscal impacts all tied to economic development and job diversification; focus on the three E's: environment, economic development, equity; septic systems - pollution; retrofitting grandfathered areas-redevelopment opportunities; density issues; critical growth and sustaining quality of life; and how to successfully move Beaufort County into the next century.

Brian Flewelling made a motion, seconded by Ed Pappas, requesting that Mr. Walters return and present an update after all General Workshops have occurred. There was unanimous support for the motion.

Lady's Island Plan Implementation Committee Task Force update – Lady's Island Village Center Master Plan concept was presented by Allen Patterson and Paul Butare. They requested a recommendation to move forward to the appropriate entities for funding of the RFP by the City and County.

Stephen Murray III made a motion to approve the Lady's Island Village Center Area Plan and forward the Plan to the County Natural Resources Committee, Metropolitan Planning Commission, and City of Beaufort Council Work Session for review. Brian Flewelling seconded the motion to approve and forward. There was unanimous support for said motion.

Discussion continued regarding the 2020 Prioritized List of Items for Consideration/Action by the Northern Beaufort County Regional Plan Implementation Committee.
